

The companies like Tata Motors, Vodafone, Khooshi Food Agency, Zydus Cadilla, Devnidhi Plastics Pvt. Ltd., Idea etc have already provided placements to our students.

Apart from associated students, the rehab center has also expanded its wings towards society as specially for people suffering from mental illness or any mental disability.



Social Rehab:

Through the Social Rehab Projects, the organization spreads awareness on matters like child depression, drug addiction, learning disorders, good parenting, naturopath in mental health etc. The center had held seminars related to above issues at various schools like Hiramani, Tulip, SSRVM, Prashant, Kid zee etc.

The trust also gives training to those who are capable of taking social responsibilities under this project.

Additionally, free medical camps regarding diabetes, blood donation, eye check-up, psychiatry check-up, dental check-up for manodivyangs has been arranged.

Vocational Training:

Under this the center arranges workshops once in every month. In this workshop they learn to make different things which can be sold in the market and they can earn through it. Few examples are floating rangoli, thali of aarti, candles, chocolate bouquet, paper bag etc.

The center also provides them platform to sell their products through various exhibitions and events like Monsoon mela, Navratri mela, Seasonal mela, Diwali mela, Rakhi mela, Wedding mela etc in various clubs and foundations alike Rajpath club, Genius foundation, Jagruti foundation, Lioness club etc.




