



## ANNUAL REPORT (2022-2023)

**INTRODUCTION:** The Independent Living Trust was created in the year 2009 by Shri Th. Saratkumar Singh as a Founder Member of the Trust, who took part in the movement of National Federation of Parents Association since 1996 representing Parents Association, Manipur for enactment of National Trust Act 1999.

The Trust was registered on 6<sup>th</sup> July, 2009 under Registered Number 1587 of 2009. But again for inclusion of additional members it was re-registered under the Trust act on 9<sup>th</sup> April, 2013, Regd. No. 722 of 2013. The primary objective of the Trust is to empower and rehabilitate the persons with developmental disabilities to live independently through special education, therapeutic and economic rehabilitation approaches with advance technologies in all areas especially rural, urban and tribal areas of Manipur.

With the above primary objective in mind the Trust felt that there is in need of a special school or a center to train the children/persons with Developmental Disabilities in daily living activities for self-care, functional academics, creativity, pre-vocational etc. and also to provide therapeutic/medical services for improvement of their mental and physical abilities like sports and games, yoga, occupational therapy, physiotherapy, psychotherapy, dance, music etc. Thus, the trust started running a residential special school for children with intellectual and developmental disabilities including children with Autism and cerebral palsy since 2011 at the trust's office building at Imphal, accommodating 15 children in the beginning. Many parents approached for admission in the school and demand increases since 2014 tremendously. But, due to lack of proper infrastructure in the office complex the school could not accommodate/entertain all the needy persons. In the wake of COVID 19 and for want of proper infrastructure, the school could not be operated since 2019.

The Trust planned to shift/operate the school at a different location where proper infrastructures could be provided. A land measuring about 4500sqft at Hiyanghang about 14km from the office of the trust has been acquired under the ownership of Smt. K. Manileima Devi, Secretary/Trustee Member of the Trust to start a Centre (special school/rehabilitation) for residential care and rehabilitation in the near future. The land and building of the Present Office of the Trust is under a lease agreement from the Owner Smt. K. Manileima Devi, Secretary/Trustee Member.

ACTIVITIES 2022-2023:- Leaving the operation of the school, the trust has started focusing its activities since 2020 on conduct of 1. Awareness program on various facilities, schemes, etc. available for the benefit of persons with disabilities. 2. Community and Home based rehabilitation program 3. Parents and siblings counselling and training. 4. Workshop/Seminar/Meeting on various issues related to Acts and Schemes for the welfare of PwDs. 5. Training and competitions in the field of Sport, Yoga, Dance, Music etc. in the community, district and state level for the empowerment of persons with PwDs in particular Autism, Cerebral Palsy, Intellectual and Multiple Disabilities.

Holding of sensitization programs, health camps, conduct of sports and cultural events, home and community based rehabilitation programs, etc. were the main activities of the Trust in this year 2022-2023.

On 7<sup>th</sup> April a health camp for dental assessment of persons with intellectual and developmental disabilities was organised by the trust at B.B. Paul Mental Development Home, Imphal. 70 students from schools and centres for persons with disabilities were assessed in the camp and advised for follow up care and treatment. 7(Seven) Dental Doctors and 5 physiotherapists provided voluntary services in the camp. Shri Ng. Utam, Director of Social Welfare, Manipur and Dr. Th. Suraj Singh, Prof. of Neurology, RIMS were among the distinguish guests present in the program.




