

His daughter 'Sirisha' is continuously inspiring and motivating her father and other family members to be more innovative and creative in serving the needy people as a change maker on life cycle basis with better sustainability as a solution to the concern of every parent that "what will happen to the child after us?"

1. ABOUT THE ORGANIZATION

'Sirisha Development Trust (SDT)' is the registered (registered under Indian Trust Act on 23rd May 2020) as a voluntary professional service organization on 'not for profit' basis with priority to work for Intellectual disabled children and oldAge people, Students, Orphans, Youth and other vulnerable groups giving priority to the rural and urban slums of Krishna & NTR Districts of Andhra Pradesh and successfully completed its 5th year of service journey (2020 – 2025). SDTworks with specific Genesis, Vision, Mission, Targeted Groups, and Objectives, and briefdetails includes:

Genesis: A father having a daughter with disabilities who developed a Service Forum (SDT in 2020) has transformed his experiences of **Intellectual disabled children**, elders, students, youth and other poor people into another Service Forum known as 'Sirisha Development Trust (SDT)' to work for their Care cum Rehabilitation, Development, and Inclusion as an Empowerment. Service Forum developed under his guidance known as SDT and will work with better opportunities, connectivity, mobilization, sharing, understanding and collaboration with the motto of multi sectoral and multidisciplinary approaches for achieving better solutions with sustainability.

Vision: Children & Adults with Intellectual & Developmental Disabilities (IDDs), Elders and other vulnerable groups who have contributed significantly to the growth of their Family, Community and Nation should lead active, happy, and healthy life with dignity and respect in an accessible and inclusive environment / community.

Mission: To work for the **Intellectual Disabled childern** and active, happy and healthy living of the elders and other vulnerable groups in an accessible, friendly and inclusive community / environment by providing matching services and supports covering health care, nutrition, and other day to day living needs at Home, Community, and Centers.

Targeted Groups: Includes Disabled ,Elders, Children, Orphans, Youth, Family Members, Relatives, Community Members, Health Workers, Social Workers, Anganwadi Workers, Teachers, Students, Youth, Volunteers, People's Representatives, and other Stakeholders.

Objectives: The key objectives of the organization include:

- 1. Work for welfare of Children & Adults with Intellectual & Developmental Disabilities (IDDs
- 2. To conduct Awareness Camps on various social needs / issues like: Health, Water, Sanitation, Hygiene, Housing, Disability, Food / Nutrition, Education both Normal & Special, Employment / Livelihoods, Environment, Ageing, and other associated areas.
- 3. To conduct Medical Camps for Children, Women, Youth, Old aged People and otherswho are vulnerable for health related issues.
- 4. To establish Homes for Senior Citizens / Old Aged People with Day Care, Residential and Community based services and supports.
- 5. To organize and / or support the Trainings, Workshops, Conferences, Seminars and other forms related with Health, Education, Environment, Employment, Livelihoods, and other Social Areas of the targeted groups & communities.

- 6. To publish and /or support for publication of Pamphlets, Newsletters, Booklets, Books, Journals, and other forms for documentation and dissemination to the larger groups through all means of communication.
- 7. To raise funds by way of Grants for Projects, Sponsorships and other means from Government, Private, Banks, Corporate, Rotary Clubs, Lions Clubs, Financial Institutes, Funding Agencies both National & International, Foundations, Trusts, Philanthropists, Donors, Elected People's representatives and other Stakeholders.

8. PROJECTS

In view of the priorities and demand from the People and Communities, SDT has conceptualized and developed four Projects as Service Providing Centers and are shown below as:



with Detter Protection, Dignity, & Respect in an Accessible and Inclusive Environment / Community

SDT focuses on all these Four Projects which are need based matching to the challenges, vulnerabilities, living environment, skills, community needs, resources & opportunities, and other aspects of empowerment of the targeted groups for bringing change in their lives with better sustainability in an accessible, healthy and inclusive environment / community. Out of these Four Projects, the first one is the continuation from the last year

(2020) and other three Projects are the addition during the last year (2023 - 2024). The details of each Project were furnished below as:

1. Sirisha special school): SDT has continued this Project for intellectually disabled chidren who are poor and vulnerable even for day to day living. Based on the survey, 3 0 c h i l d r e n (Male 17 & Female 13) were identified who are poor, vulnerable and marginalized living in the rural parts of Gudivada and surrounding Mandals of Krishna District. Andhra Pradesh.

In addition, 5 more members (Male 3 & Female 2) who are part of the team also gets the same supports and services. These children are isolated and struggling for day to day needs and thus leading poor quality of life (QOL). The pandemic and post pandemic emerged due to Covid 19 has added burden to them both socially and economically. This is the Day Care Project and all the required services and supports were provided at their Home / Shelter itself.

In view of all such unhealthy and unsafe circumstances situated around these targeted Elders in general and particularly during and post pandemic (Covid 19), the services and supports extended during the year includes:

- ✓ Kitchen with required utensils and other machinery are maintained at the Center.
- ✓ Team takes care of the Cooking, Packing, and Distribution to the Elders at their Home.
- ✓ Cooked Food (Carriers with good menu) delivered at their Home on Daily basis.
- ✓ Distribution of Dry Ration & Vegetables at their Home on Monthly basis.
- ✓ Distribution of Sanitizers, Handwashers, Medicine, and other Supports.
- ✓ Health Care mostly on referral mode at Government and Private Hospitals.
- ✓ Other services and supports matching to individual's needs, challenges and vulnerabilities.

For these beneficiaries, SDT has also conducted various Activities / Programmes (covering: Systems, Values, Relationships, Cultural, Recreational,

Awareness cum Advocacy, Facilitation, Referrals Services, Social Benefits, Legal Issues, Issues connected with Properties if any, and others) at Center, Communities, Public Utility Centers, and other such Forums to the Elders, their Family Members, Community Members & Workers, Community Groups, Civil Societies, and others and other Stakeholders for the purpose of creating happy, healthy, protective, safe, and accessible environment for the Elders within the Families or Communities as they do have emotional attachment with their Family and Community.

In view of the limitations, SDT is managing this Project based on the Donations and Supports received from the well-wishers and others from the community and other Donors of SRC & itself. All such supports are not regular and SDT is finding difficulty to continue this Nobel Service of working for the active, happy and healthy living of the Elders within the Home / Community. It is in the process of reaching the Departments of Government, Private, Corporate, Financial Institutions, Funding Agencies, and others for getting matching supports on regular basis both to run this Project as well as to strengthen it to reach several such elders living in the rural and urban slums of selected mandals of Krishna & NTR Districts and its surrounding Districts of Andhra Pradesh.

2. Sirisha special school): SDT has started this Project in the last year (2023 – 2024) for the Children (age group of 5 to 18 years who are having single Parent, no Parents, or living with Relatives) living in rural and urban slums of Gudivada and SURROUNDING Mandals of Krishna District and other parts of NTR District of Andhra Pradesh. This was emerged based on particularly due to the challenges, vulnerabilities, and family crises resulted due to the pandemic of Covid 19 (both during and after).

Under this Project, various benefits extended include: Health Care, Dress, Food, Education, Cultural & Recreational, and other Services & Supports have been extended to 30 Children (Boys 14 & Girls 16) on Day Care cum Residential Care (with the support of Centers of SRC) who were identified during and after the Pandemic of Covid 19. All these 30 Children were identified by the teams of SDT while doing their regular services to various targeted groups and connectivity with various Stakeholders at Community level.

SDT has shown keen interest and conducted various other Activities / Programmes covering various aspects which includes: Awareness cum Advocacy,

issues of Orphans, challenges & opportunities of orphans, causes and consequences of forcing children as Orphan, stigma and isolation from the mainstream, database of orphans, various acts, rights, & provisions / benefits, opportunities for mainstreaming Orphans at all levels, strengthening the systems and service delivery, mechanism of designing, implementation, monitoring & evaluation, preparing the families and communities to support orphans, cultural & recreational activities, exposure to ability

shows, visit to marketing places and other public utilities, and other need based to prepare them for better living in an accessible and inclusive environment / community with sustainability.

This is the Project started in the last year (2023 – 2024) and SDT is managing this from its internal resources mainly raised from the individual donors, wellwishers, donors of SRC and need based supports from SRC itself. Trust is in the process of preparing the Project Proposals for submitting to Departments of Government, Private, Corporate, Funding Agencies, and other such Agencies / Departments. SDT is making its process of Resources Mobilization to strengthen it, to scale up to reach the unreached and replicate in other parts of the rural villages and urban slums of the Krishna & NTR Districts of Andhra Pradesh.

3. Sirisha CBR Services (SCBRS): SDT knowing the limitations and challenges of running Center based, SDT mostly works with Home Based Services and Supports to various targeted groups and provisions under various National and International Acts & Policies. Trust has realized, understood, and get equipped to shift the Service Delivery System (SDS) of Center Based and Home Based to Community Based known as 'Community Based Rehabilitation (CBR)'. CBR is defined as the "Strategy within the Community Development that aims at enhancing the lives of Children and Adults with Disabilities (PWDs) within their Community with equality, equity, dignity, respect and rights".

It is well defined that "CBR is a multi-sectoral approach working to improve the equalization of opportunities and social inclusion of people with disabilities while combating the perpetual cycle of poverty and disability". CBR is implemented through the combined efforts of people with disabilities, their families and communities, and relevant government and non-government covering health, education, vocational, social and other services. CBR Matrix matrix consists of five areas / domains headed as Health, Livelihood, Education, Social and Empowerment and each cover five elements. Though CBR works for general rehabilitation of all vulnerable groups, but limits to

Disability Rehabilitation as a model of Development with better Access and

Disability Rehabilitation as a model of Development with better Access and Inclusiveness.

In view of the rights and other provisions given in UNCRPD 2007 and RPWD Act 2016, SDT has given priority to work on this model of CBR as it is Community driven with better participation, accountability, responsibility and transparency (PART). This is the Project initiated in the last year (2022 – 2023) by the Trust (guidance and support from SRC) and 30 Children and Adults with Disabilities (Male 14 and 16 Female) living in rural and urban slums of Pamidimukkala, Vuyyuru and its surrounding mandals of Krishna District & parts of NTR District of Andhra Pradesh.

The CBR Project provides Services and Supports for Children and Adults with Disabilities with focus on Intellectual and Developmental Disabilities (IDDs) which includes: Awareness cum Advocacy on the causes and consequences of disabilities, Medical Camps, Screening Camps, Early Identification, Screening cum Assessment, Certification, Early Interventions, School Preparedness, Mainstreaming, Education, Training cum Rehabilitation, Vocational Training, Employment, Livelihoods, Aids & Appliances, Identification of Barriers and Action Plan for their removal, Prevention of the causes of Disabilities, various Schemes and Benefits, and other aspects connected with Disability, Poverty, and Development with Bottom up Approaches (BUAs). This project is in the beginning and will get associated with SRC for strengthening the same to reach several such children and adults with disabilities as specified in various Disability Acts & Policies.

On collaboration, SDT works for making it more effective and efficient to reach the targeted Children and Adults with specified disabilities and to strengthen this project in all aspects covering: Legal, Administrative, Technical and Financial (LATF). Since last two years, Trust has managed this Project on its own with the support of individual donors, wellwishers, supporters. Trust felt itto run the Project difficult with such unsecured supports and it is in the process of submitting need based Project Proposals to Departments of Government, Private & Corporate (under Corporate Social Responsibility – CSR), Funding Agencies and other such Departments / Agencies.

4. Sirisha Vocational Training Center (SVTC): SDT has conceptualized and developed this Project for the Adults with Disabilities (with priority for Adults with Intellectual and Developmental Disabilities – AWIDDs) who have already got trained in some of the Projects of SRC and SDT. This Project is also known

as 'Vocational Training cum Skill Development' with focus on improving the employability for open employment as well as creating Livelihoods with matching resources and needs from the local Communities. This is the Day Care Project providing all the need based training at Center (), Home and Community.

On need based, the Trades initiated during the year (continued from the last year 2023 – 2024) includes: Surf Making, Candle Making, Toys Making, Painting, Tailoring, Phenyl Making, Garments Making, Cooking, Gardening, and other Family based trades / vocations / business. During the year, **22** Adults (Male 14 and female 8) with Intellectual and Developmental Disabilities (AWIDDs) got the benefit of Vocational cum Skill Development Training.

While imparting Vocational Training cum Skill Development in the selected Trade / Vocation, steps followed includes:

- ✓ Assessment of the needs of the Beneficiary along with their Parents,
- ✓ Selection of Trade / Vocation,
- ✓ Selectin and Mobilization and Processing of Raw Materials,
- ✓ Demo of the Products to be made in the proposed Trade / Vocation,
- ✓ Preparation and Production of the Product,
- ✓ Packing and Labeling of the Products based on the Consumer needs,
- ✓ Showcasing the Products at Exhibitions, Public Utility Centers, and at other possible Forums,
- ✓ Quality, and Value addition with Branding to the Products,
- ✓ Networking, Connectivity, and Referrals for Marketing the Products,
- ✓ Placement at the respective Employers / Industries / Establishments for observation cum preparedness for suitable Employment / Livelihoods, and
- ✓ Preparation cum mobilization of Parents / Siblings / Grandparents to be pat of their ward's training and facilitation for suitable employment preferable for Self Employment, Group Employment (by way of forming Self Help Groups SHGs), Microentrepreneurship, Startups, Family Business, Sheltered or Protected Employment and other possible forms of Income Generation Programme (IGP) which leads for their Economic Empowerment along with Parents & Family Members.

Under SDT, this Project is in the beginning and will be strengthening by adding more and more need based Trades / Vocations and such needy Adults (18+ years) with specified disabilities. Trust is managing this Project on its own from internal resource mobilized from Management Committee Members, Wellwishers, Individual Donors of







- Other Programmes conducted are need based and supported to reach the unreached with better Awareness cum Advocacy, Scope for Referral Services, Social Benefits and its Utilization, and ways to be part of the mainstreamed Environment / Community.
- ➤ Celebration or joining in the Celebrations on various events of National and International have opened-up various opportunities for networking and connectivity with scope for the identification and sharing of common resources.

13. SUPPORT US



Organizational Structure:




