Being a Residential Home for the Intellectually Challenged Children, Ashraya's Summer Vacation commenced from 25th March 2020 and all our Intellectually challenged daughters left for their home for Summer Holidays.

Unforunately by end March 2020 the Covid Pandemic spread throughout the Country.

As per the direction of the Kerala State Government the Educational Institutions were not allowed to open till date.

However Ashraya initiated Online Classes for its Intellectually Challenged Children from 1st June 2020 onwards even much before the State Govt. cane out with this concept.

Ashraya is still continuing this Online Education Programme which includes the following Skill Training /Development programme.

- 1. Functional Reading, Writing & Arithmetic Skill Training.
- 2. General Knowledge.
- 3. Time & Money Concept,
- 4. Physical Exercise & Yoga.
- 5. Music & Dance.
- 6. Domestic activities.
- 7. Vocational Activities.
- 8. Recreational Activities.

The response from the children and their parents are extremely good. All Ashraya daughters are actively participating in the Online training.

Out Reach Programme During Covid Pandemic Situation

All Ashraya staff have been highly engaged during this pandemic period in contacting over 7000 families known to us in the State and enrolled in the Niramaya Insurance Scheme.

Ashraya could extend support both morally and material wise using the network of the great organization 'Seva Bharathy'. Those who required medicines, food, diapers etc.,etc. were supported with extremely well through Ashraya's efforts which are still continuing.
