



During 2000 SPOORTHY registered and started collection of seeds, raising nursery, planting trees, organizing self help group, income generating programme, linkages with Banks and Line Departments. Slowly the activities expanded to multiple district and State. Taken up intensive activities at the grass root, and extensive awarenss through campaign mode in the State. 

## **Executive Summary of the**

Annual progress report - 2021-22:

The organization, in its 22nd year on this auspicious occasion, has focused on enhancing the capacity of its target community - women, children, the vulnerable, the poor, the landless, the exploited classes - as well as on the people organizational



growth. A promising development has taken increasing capacity of the staff, eco-system management, resource mobilization, networking etc.,

In phase-out project area (after withdrawal of the project by the donor agency), Spoorthy extended monitoring support by capacity develop on leadership, linking with other projects and networks (Federations and Unions). Further linkages developed with similar other affialiated groups/ organisations working at State and National level.

Our Administrative works were strengthened by taking all updating in FCRA renewal and got five year registration (April 01, 2022 March 31. 2027) extension. Further as per the amendment ot FCRA the Bank account opening process at SBI, New Delhi is also completed and we filled all the relavant documents with the authority. Society

renewal as per KSRA 1960, filed Income Tax returns, got registration updated under 12A and 80G Income Tax Act for further 5 years. software updating, and all other statutory obligations of the organisations were updated. Organisation got registration at Niti Ayoga and National Trust.

Diversified livelihood, integrated support and need based quick financial assistance were extended to Self Help Groups, which brought several socio economic impact at village level.

# **Operational Highlights:**

- 1) Improving Livelihood of the Farmers of Bagar Hukum and Forest Land Cultivators: 656 farmers got 1215.13 acre land rights under Recognition of Forest Rights Act 2006 and 2013 farmers got 4536.08 acre land rights under Karnataka Land Revenue Act 1964. Among 656 farmers 410 farmers got pahani (Land right record) under Forest Act and out of 2013 farmers 1945 farmers received pahani (land records) under Revenue Act.
- 2) Child HelpLine Sub Centes, Awareness programme conducted in 122 school and addressed 12,030 children and 850 adults. Outreach programme organised for 12,300 children and 210 aadults. Four Open house programme organised and covered 1,250 children and 870 adults. 18 Dosti programme organised and covered 1750 children and 870 adults. 17 training programme organised for SHG women and other Community Based organisations representatives and awareness created to 265 representatives
- 3) Evaluation of S.P./T.S.P programme of Social Welfae Department: This evaluation study was taken in 6 taluks of Chitradurga district viz., Chitradurga, Challakere, Molakalmoor, Holalkere, Hosadurga and Hiriyuru taluks. Intervied and information collected from 429 benificiaries according to structured questanares as per below table
- 4) Early Intervention & Early Education (EI&EE): The center is taking care of 25 children. Support of the center 3-6 ae group 12 children are now going to Anganawadi and 12 children to lower primary school. ID card given to 12 children and 25 children got Nirmayi card. U.D.ID card got 20 children. The children in critical condition cases reffered to Davanagere and Bengaluru hospital for higher treatment
- 5) Biofuel Development in Davanagere district: 275 farmers motivated for planting biofuel seedlings in their farm land under MGNREGS. Awareness creaed to 248 school children. Environment, World biofuel Day celebrated. Nine training pogramme organised for Farmers of the all 6 taluks of the districts.
- 6) Awareness programme on Renewable Energy: Spoorthy organised awreness on Renewable Energy programme in Davanagere Disrict with the support of Mahatma Gandhi Istitute for rural Energy Development (MGIRED) Bengaluru. Solid Waste Management training programme organised to Women SHG Federations representatives.
- 7) Identification of Common Resources, Protection and Development Activities: FES and Spoorthy, jointly working on development and identification of Common Resources in Davanageredistrict. 30,00 acre land identified, Villae Environment Protection Comitteeformed in 111 villages. Working with 63 GPs and prepared action plan for the development of Common Resources under MGNREGs by involving ZP, TP and GP.

- **8) Programme on Peace and Harmony::** We are all the same human beings live together and continue with same spirit and harmony in the society. With this context Celebrated of protection of community resource day was organised on 29.10.2021 at, Davanagere,
- **9) Strengthening SHGs and Economic Empowerment:**, Spoorthy linked SHGs with different Banks and Financial Institutes, Rs.5.41 crore credit linkages availed by 98 SHGs and taken viable income generating activities (IGAs).
- 10) Water harvesting strcture and Natrual regenerations: 4670 members include Women, Physcally Challanged, widows other marginal community in Laborers group. etc., are organised as labour groups. They got 100 days employment, full wags and involved planning development of tanks, cannels, pitting, planting, watering, pasture development etc., As a result ground water recharged, animals and birds getting water, green cavarage enhanced in hills and common lands.
- **11)Strengthening Groups and Network at Different Level: Under** MGNREGS labours Group strengthened and developed linkages at Village, Taluka, District and State forum. They are actively participated and expressed their views in planning and execution of the MGNREGS.
- **12**) **Mahila Santwana Kendra at Honnali:** During the year 28 cases registered among 22 on domestic violence, 2 on property disputes, 1 dowry harassment, 1 on discrimination from neighbours. Among 21 cases resolved, 2 cases on domastic violence referred to Police Station and 2 cases reerred to CDPO.
- 13)Covid Vacination and Humaniterian services: Vaccination drive conducted at Davanagere and Chitrudurga district along with Health and Family Welfare Department, and Jain Association of India. Different i media campaign organised with support of Appolo Hospital. Vaccination camp specially organised for physically challenged persons of all six taluks, Davanagere with the support of D.N.A. Disable Allance Network. Another Special vaccination drive organised in all six taluks of Davanagere district by involving different stake holders, food kit distributions, mask, sanitization and toher health care materials distributed.
- **14)Skill training to Physcally challangd Person's:** Computer skill developmenting training programme organised to Physcally challangd youths of Davanagere.
- **15)Vocational Training to School Dropout Youths:** The skill training organised continued with the support of FVTRS. 125 School droup-out traind in Fashion designing, Knitting, Embroidery, Security Guard, Cheff and Bakery, Salesman and Receptionist.

Following are the detailed activities, programs and interventions carried out during the year 2021-22.

# 1) Improving Livelihood of the Farmers of Bagar Hukum and Forest Land Cultivators:

The organization has been working on improving the quality life of the farmers in 8 Assembly constituencies of Davanagere and Chitradurga districts through Karnataka Land Rights Forum.

Organisation worked with the Government for the implementation and getting land rights to eligible farmers under 'The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, and (ii) Legalization of

Unauthorized Cultivation as per Karnataka Land Revenue Act, 1964.

Through affected People's Forum the organisation facilitated to get land rights, then started 1.Awarness and organizing throse farmers, 2. Increase the productivity of the land, 3.



Mitigating measures for ill effect of drought and flood and 4 Forum strengthening – these four activities taken up during the year.

The organization identified bagar hukum and forest dependent farmers and organized them through village level forums. Various capacity development and empowerment process organised. Updated the information and knowledge on government systems and procedures. Used government circulars, orders; telling success storiesof other parts of the State and built their confidence. Farmers network further developed from village to Taluk, Vidhana sabha constiency area and district level. Through training, workshop, meeting, information desimination and other strategies were formulated to access their land rights.

Continuous lobby and advocacy were done through peoples network withimplementing Officers, MLA, MLC, Ministers of Revenue, Minister of Forest, Minister of Social Welfare and Chief Minister. Direct contct, dialogue, submitting memorandum for their demand.

As an impact of the sustain demand finally Government of Karnataka, Revenue Department issued circular to speed-up for issuing Land Records to benifiaries. Under the Forest Protection Act application of the scheduled caste were settled and the issue of land records got momentaum in the State. Most of the Bagar Hukkum land were reserved for 'Grazing land' so the hurdle started, efforts stuck down. Eventhough Government issued for one time settlement of Grazing Land and gazettee notification in Feb. 2017 this move was challenged in High Court, again process of land record issue was further stopped. High Court

settled the problem and the process of land record is again started by the authority.

Due to the Spoorthy intervention in Davanagere and Chitradurga district 656 farmers got 1215.13 acre land rights under Recognition of Forest Rights Act 2006 and 2013 farmers got 4536.08 acre land rights under Karnataka Land Revenue Act 1964. Among 656 farmers 410 farmers got pahani (Land right record) under Forest Act and out of 2013 farmers 1945 farmers received pahani under Revenue Act.

Drought and Flood disaster management mitigation and reducing losses were discussed and mapping exercise done on hazards control and prepared action plan. Village level to distristict level empowering farmers organisation organised through regular meetings, trainings and resource mobilisation.

The proposed target implementation for the The Scheduled Tribes and Other Traditional Forest Dwellers to access title deeds for the land in their possession is needed; it takes another one year to work in the project aea.

#### 2. Child HelpLine Sub Center, Honnali and Chennagiri:

With support of Ministry of Women and Child Development, Government of India,

New Delhi and Concern India Foundation, Mubai the project Child Helpline sub-centres successfully continued at Channagiri and Honnali taluks.

conducted through conduct regular Awareness meetings, discussion, open house meetings, night meetings and house visit etc., Children and parents were involved actively in these interventions. field visits and interaction have been continued. Other stake holders and community organisation representatives were involved in Open huse meetings and outreach programmes. Grama Sabha conducted by involving SHG members and Village accountant. Organised Dosti programme and involved College Principal, Health workers, Auto drivers, Grama Panchayat members, Teachers, Asha and Anganawadi Karyakarteyaru.



During the year, a total of 1038 children were protected by the Child Helpline Centre on different types of help and complaints. Most of the casses are on child marriage, missing, seeking help from parents, sexual abuse, child labor, children begging, medical help, food grains not being distributed properly in Anganwadi, mental and physical assault punished by teachers in school. Hence Child Helpline addressed all these complaints and protected children from disorders.

Awareness programme were conducted in 122 school and addressed 12,030 children and 850 adults. Outreach programme organised for 12,300 children and 210 aadults.

Four Open house programme organised and covered 1,250 children and 870 adults. 18 Dosti programme organised and covered 1750 children and 870 adults. 17 training programme organised for SHG women and other Community Based organisations representatives and awareness created to 265 representatives.

Awarenes created to 325 members of different Community Based Organisations viz., SHGs, Youvaka sangha, Auto drivers, Meena, Child club members and other stake holders. Total 106 officers including Police, Grama Panchayat, Women and Child Welfare, School Teachers were attended in those training programmes. At District level DC, CEO, SP, State Commission for Child Right Protection members meeting and discussion were held.

## **3.** Evaluation of S.P./T.S.P programme of Social Welfae Department:

Social Welfare Department, Government of Karnataka implemented selected programmes/schemes impact evaluation study taken up jointly by Public Affairs Centre (PES), Bengaluru and Spoorthy, Davanagere. This study was taken in 6 taluks of Chitradurga district viz., Chitradurga, Challakere, Molakalmoor, Holalkere, Hosadurga and Hiriyuru taluks. Intervied and information collected from 429 benificiaries according to structured questanares as per below table.

From this Evaluation, e found that people have lack of knowledge on the scheme and less awareness efforts were done. Some schemes not implemented properly. SC and ST people got some land ownership, these lands ae not suitable for cultivation. These lands allotted 10 to 15 k.m. distances from the benificairy home. At present not using these lands and not getting any benifits. Children got scholarship. Mini water tanks constructed mainly in several place and many more needs to be constructed. Some old tanks added in the list, found that list provided to us is not true and the assets not maintained properly. The implementing Officer not got training and the assets not transferred to concerned Grama Panchyath. Agriculture equipment districtuion, generator set and farm pond are not given or constructed. The complete evaluation report consolidated and submitted to the Government.

#### 4. Early Intervention & Early Education (EI&EE) to improve Child Growth:

Association of People with Disabilities (APD) support for this programme ended in the middle. EI&EE program is carried for 0-6 year children in Channagiri Taluka of Davangere District Spoorthy continued this programme continued since 2016. The progresses of this continued project during 2021-22 are;

During last five years under this programme 25 children's were managed. Two experienced staff team are working in the project. The programme is coordinated through "Jeeva" center. With the support of Health Department and Grama panchayath 0-3 age group 10 children and 3-6 age group 15 children identified. Development and growth check list assessment and assistance extended and given therephy for the physical growth.

The children in critical condition cases reffered to Davanagere and Bengaluru hospital for higher treatment. The team is taking care of 25 children. Each week change over exercise are conducted, apart from this activities demonstrated in 12 sub centers. 3-6 ae group 12 children are now going to Anganawadi and 12 children were going to lower primary school. ID card given to 12 children and 25 children got Nirmayi card. U.D.ID card facilities aviled by 20 children.

Four days residential trainings were organised for different stake holders like GP members, Anganawadi teachers, Asha karyakarte, SHGs, PHCs, VRWs, MRWs, RBSK etc., Children's Day and World Physically Challenged people's day celebrated at Jeeva Center. Health check up camps were organised and created awareness to public.

#### 5. Biofuel Development in Davanagere district:

Spoorthy has been working with Karnataka State Bioenergy Development Board (KSBDB), Bangalore as Lead NGO for the Davangere District for promotion of Bioenergy Development programme through community participation. Under this project motivated farmers, school children's and communitybased orgaisations.

On 5/06/2021 Environment day was celebrated at Narasagondanhalli near Davanagere. Plantation activities caried in forest area, banks of the lake. The programme jointly organised Zilla Panchayat, Forest Department, Gram Panchayat and Spoorthy. Local laborers and farmers wee involved. Awareness created to farmers about the uses, cultivation, conservation, environment and biofuels to the public. . About 162 people participated in this progrmme. Chief Executive Officer Mr. Vijaya Manhantesh Dyanavar, ZP Deputy Secretary Sri



Ananda, Deputy Conservator of Forest Sri Rajanna, Director of Spoorthy Sri K.B. Rupanayka, Zonal Forest Officers, Assistant Conservator of Forests, President, P.D.O., Panchyath Chairman, Forest Department officials participated.

On 10/08/2021 The World Biological Day was celebrated near Davanagere with the support of Zillha panchyath, Davanagere. Awareness programme organised farmers, school children and other public on the importance of biofuels. During the occation 1500 biofuel sapplings planted in road side, school grounds and forest area.

275 farmers motivated for planting biofuel seedlings in their farm land under Awareness creaed to 248 school children on biofuels MGNREGS. discussion, plantation and othe activities.

Nine training pogramme organised for Farmers of the all 6 taluks of the district and the village laborers on the use and cultivation of biofuels, alternative fuels, conservation, reuse in the empty space of the scommon properties. In this training, 429 people participated. Farmers were sent Biofuel Research, Information and Demonstration Centre, KVK, Davanagere for technical trainins.

#### 6. Awareness programme on Renewable Energy in Davanagere district:

Spoorthy organised awreness on Renewable Energy programme in Davanagere Disrict with the support of Mahatma Gandhi **Istitute** for rural Energy Development (MGIRED) Bengaluru.

and Implementation Solid Waste Management training: The training programme on Solid Waste Management was organised to Women



representatives of Davanagere district SHG Federations. The training jointly organised by MGIRD, Z.P, Davanagere and Spoorthy organisations. 150 women representatives were participated in this 5 days residential training programme. In the closing function ZP, Deputy Secretary, J.D, Agriculture Departmrn and Spoorthy organisation Officers were attended.

Organised Eight batch training programme on solidRenewable energy training programme was organised Belalgere School.

# 7. Identification of Common Resources, Protecion and Development Activities:

Foundation for Ecological Security (FES) and Spoorthy, jointly working on

development and identification of Common Resources in Davanagere district. The organisation taken survey and identified gomala land, C&D classification land, Grzing land, Waste land, Sendhivana etc., in 6 taluks of Davanaere district. Total 30,00

# A Success Story Daginakatte Common Resources: Action by Local Committee

The Daginakatte is situated in Channagiri taluk of Davanagere district, This village is surrounded by 4 hills called as Gudda and deep slops due to deplation of the green coverage. A road is passing through the middle of the village to Yalodalla village.

Spoorthy organization working in theis village since 15 years. Initially taken up rapport development and understanding their problems. Based on the requirement formed women Self Help Groups. Started income generation activities. Then identified landless and marginal community youths, formed Labours groups under MGNREGS. Motivated them to access job under the act and strengthened institutional structure. Different interventions helped to get sustainable socio economic condition in the village.

About 1000 target family women and men labourers formed their own SHGs and Laborer groups. The credit facilities from the bank and government schemes obtained by the SHGs. Women and labourers got employment under MGNREGS. Spoorthy also helped them for savings, thrifts and credit activities, book keeping, repayment, finance management, leadership and exposure to other places build their confidence and ownership. Women successfully taken up dairy, sheep and goat rearing, petty business, agriculture and allied activities, tailoring, etc., Earlier Panchayat and corrupt system (elected representatives, contractors and as well officials) prevented laborers to access job and suppressed their voice, they are afraid to express or raise voice in the village. After group formation and empowerment process they got confidence and voice in the village. Overall our various intervention improved their economic conditions, stop migration to urban and for distance place in lean period and helped them to stay at native.

**Summary:** It is observed that water scarcity is not there comparing to the previous year. Plantation in the hill arresting runoff waters. Tanks dried from, several years is filled, The ground water table recharged well. Open well and bore wells recharged, several years it was completely dried. Drinking water availability also improved. People saying that they will get ground water at 300 to 400 feet depth, earlier it was 700 feet and above. cattle's getting enough water and fodder from common resources, tanks and gokatte. So the Common Resource Committee enlighten that Common Resources are the resources and development of the our village, and it "Our Resources and Village Resources.

As per Panchayath Raj Act 1993 section 58 (a) says that Grma Panchyath is responsible registrering its common resources, protection and development. Further the section 68 says to form sub committees by Grama Panchyath for implementation of the responsibilities. above Accordingly Spoorthy done intervention for formation of "Grama Parisara Abhivruddhi Samiti" (Villae Environment Protection Comittee) in 111 villages. The training programme organised to sub committee members.

Action plan prepared for the development of Common Reosureces under MGNREGS programme. Importently the asset registration under format No. 30 has taken up in all Grama panchyath. The process is first in kind in the State. Land

levelling, pitting, planting, watering and garding activities taken up under MGNREGS at Daginakate, Nelogal, Rudrapura, Hulikati etc., grama panchyath.

#### 8. Programme on Peace and Harmony:

In today's system, there is outrage, violence, pain, violence, communal riots, unrest and peace in the people, and the society is moving in the direction against Buddha and Basavanna tought. With this context, during our meeting, training, gettogether, conference etc., given importance for "Peace and Harmony" the message of compassion, love, friendship and humanitarian kind works/actions. We are all the same human beings has been live together and continue with same spirit and harmony in the society. The kind of work has been taken in the organisation to plant the seed of feeling that we are human beings.

Celebration of protection of community resource day was organised on 29.10.2021 at Zillha Panchayat, Davanagere, Spoorthy and FES, Kolara jointly organised "Peace and Harmony" programme to spread the message. CEO of ZP attended as Chief Guest, ACF, Social Forest, Executive Officer, Taluka Panchyath, DavanagereAgriculture Officer and others participated in the event.

#### 9. Strengthening SHGs and Economic Empowerment:

Spoorthy continued empowering SHGs and SHG Federations in Davanagere and Haveri districts. Facilitaed to conduct regular meetings capacity building and linkage support extended. During the year, Spoorthy linked SHGs with different Banks and Financial Institutes, Rs.5.41 crore crdit linkages availed by 98 SHGs.

As a result of timely financial support, SHG women are engaged in different types of income generating activities (IGAs). Overall support helped target family livelihood. Further developed selfesteem, confidence, trust, mutual respect respectable life in the family and aswell in the village.

#### 10. Water harvesting strcture and Natrual regenerations:

Landless Labourer, Women, Physcally Challanged/ abled persons, widows etc., are organised as labours group. Total 4670 members in Davanagere and Gadag district continued and getting 100 days job at locally. Small and medium tanks repair, desilting, canel works, are taken in common land. About 2.50 lakhs seedlings planed on common lands and farmers land. Water filled in all tanks and cannels, ground water recharged, animals and birds getting water, green cavarage improved lot and fodder also available to cattle. This helped marginal community to take up animal husbandry and agriculture activities with successful and improved their economic

#### 11. Strengthening Groups and Network at Different Level.

MGNREGS labours Group strengthened and developed linkages at Village, Taluka, District and State forum. They are accessing their right to work as per the law. They also restored transparency in the implementation of the programme. They

also actively participated and expressed their views in planning and execution of the MGNREGS programme with the implementing authorities.

#### 13. Mahila Santwana Kendra at Honnalli:

Mahila Santwana Kendra have been continued at Honnali with the support of Women and Child Welfare Department, Government of Karnataka. The purpose of this programme is that Women who are victims of various atrocities such as Dowry, rape, sexual harassment, domestic violence etc, are subjected to physical and mental torture besides having to face social financial problems. With a view to console these women and rehabilitate them, the scheme of "Santwana" was launched. The Spoorthy is the partner along with the Government of Karnataka for the implemention of the programme in Honnali.

The Center is having 4 experienced staff, it works 7daysx24 hours for the protection, secure and homes atmosphere for the rehabilitated women.

Spoorthy is created awareness aon Santwana in its SHGs and federation meeting. The center is having helpline No.1091 shared to all SHGs and its federation members. Awaqreness programme organised to SHG women, Artisan family, anganawadi Karyakarte and Asha Karyakarte.

During the year 28 cases were registered at Santawana Kendra. These caes are classified as 22 cases on domestic violence, 2 cases on property disputes, 1 dowry harassment, 1 on harrestment from neighbours. Councilling done in each cases to find solutions ad justice. Among 21 cases resolved at Santwana Kendra. Two cases on domastic violence filled case at Police Station and transferred. 2 cases transferred to CDPO and addressed all the cases with care. Following welfare activities organised with the support of other civil societies;

#### **14. Covid-19 Vaccination camp:**

- 1. **Covid Vacination camp** was organisd in Davanagere and Chitradurga district along with Health and Family Welfare Department, and Bharatiya Jain Sanghatane (Jain Association of India), during April 21-March 22. Vaccination drive organised at village and grama panchyath lelve for the age group of 18 and above. Vaccination awareness programme organised with the support of Appolo Hospital and taken Ambulance for awareness programme. Total 8654 members received 1st and 2nd dose and some were taken booser dose also.
- 2. **Covid Vacination camp** phycally challenged people: the vaccination camp specially organised for physically challenged persons of all six taluks, Davanagere with the support of D.N.A. Disable Allance Network, Bengaluru. Awarness, councelling and escart to vaccination service center

was organised. Involved different stake holders like VRW, URW, Health Workers, Asha karyakarte and Grama Panchyath members to cover all target people to get vaccination. Through this vaccination drive covered 24875 physcally challenged and their care takers. Further In this process involved VRW, URW, Health Workers, Asha karyakarte and Grama Panchyath members. PP Kit, testing kit, mask, hand glouce and sanitiser distributed to VRW, URW, Health Workers and Asha workers with support of FES.

3. Vaccination camp organised with the support of Center for Ecological Security (FES): Special vaccination drive organised in all six taluks of Davanagere district with giving special focus on Physcally challenged, widow, single women, family affectd from Covid etc., These people really suffered without job, no medicines, lack of safe water and food. Identified most vulnerable family and distributed 650 food kits to each family.

#### 15. Skill training to Physcally challangd Person's:

Computer skill developmenting training programme organised to Physcally challangd youths of Davanagere district with the support of Enable India. 30 members one bach training is on. Fter this training Spoorthy will facilitate o make them service provider, self earning from business home setup.

#### **16. Vocational Training to School Dropout Youths:**

The above project was continued with the support of Functional Vocational Training and Research Society (FVTRS) Bangalore. During the year 125 School droup-out youths have been trained in bath on Fashion designing, Knitting, Embroidery, Security Guard, Cheff and Bakery, Salesman and Receptionist. Successfully skill trainees are getting decent job, service provider and started self employment and each one is earning 7500 to Rs.12, 500/p.m.

#### **Conclusion:**

Over all, the year 2021-22 was a very productive and busy with diversified activities and innovative. We are thankful to all members of General Body, Executive Committee, Volunteers, target group and staff for their invaluable contribution, involvement and participation. Due to our different interventions a total of 22 to 25 children attended regularly in the center.

- Provided information to parents to register their children at Anganwadi and further discussed with the Deputy Director of District Women and Child Development Department about registration of children.
- Regularly at once in a month 1 or 2 day Poshak Sabha/Parental Trainings cum meetings were organized to parents of children. During these interventions the parents discussed about the problems arising in the care of children, the following problems were listed and discussed together to take forward and find appropriate solutions.
  - Child health check-up and Certificate from the doctor.
  - Getting Certificate on Percentage of Child's Handicapped.

- Aadhaar Card Identification Verification system (Child's Hand & Foot scanning Identification)
- \* Registration for Nirmaya Card.
- Two Health check up camp first one was in May 2021 and second one was November 2021 onducted in the year also. Docotr from R.B.S.K and Therapist did some therapy and provided medicines in the camp. Previous year also Health Check up camp for the children were conducted in the same schedule.
- The Doctor did some therapy activities experimentally to make the parents feel better for the child, and the parents were also strengthened mental strength.
- Children's Day was celebrated with the Child Helpline team. Discussions were held with the District Collector about the requirement of the children and the facilities of government schemes needs to be delivered to needy children/parents.
