PRESIDENT'S FORWARD

We have passed a harrowing year in 2020-21 owing to the Covid pandemic. There has been all round misery and sadness in families across the Country, afflicted by this terrible disease. Many loved ones have lost their lives. Others have had to battle with serious illness, lack of hospital beds, essential medical supplies and hospitalisation. Families have been stranded because of the loss of jobs and occupations. The two 'waves' of the pandemic during 2020 and 2021, spread a feeling of gloom and destitution in all, including the stout hearted. The worst may seem to be over; but there is more than a



lingering suspicion that we have not seen the end of the pandemic. With the start of the vaccination drive by the Government in January 2021, there was a glimmer of hope that the scourge of covid could be prevented.

The AMC Community was badly affected and disrupted in the year under review. As a preventive measure and to encourage 'stay at home' for its beneficiaries and staff, the MC took a considered decision to close AMC. Hence, all activities came to a grinding halt in late March, 2020 and remained so during the year. The campus missed the beat of our excited beneficiaries in the Special School, Vocational Training Centre, Sheltered Workshops and the myriad other activities that comprise AMC.

Despite all stated above, we endeavoured to maintain a degree of 'normalcy' in our work. The monthly regular MC meetings held every month through video conferencing, helped in regular reviews of our financial position, and execute activities among the beneficiaries and their families.

The Secretary's report will have details of all activities. I wish to emphasise the following: (a) AMC provided counselling through WhatsApp and calls to anxious parents and their wards confined at home (b) We extended monthly support through essential supplies and rations for families since most breadwinners were out of jobs in the pandemic (c) Home delivery of training and teaching materials to families, including videos and customised lesson plans, for special school students, (D) raw materials supply to homes to maintain production of products for which AMC is famous (E) income support to select parents through making of masks at the centre. For each of the households, we supplied hand sanitizers and hygiene items for protection.

Continuing with AMC's efforts to empower the families of those affected with IDD, this year we have initiated visionary project ENRICH. ENRICH is being helmed by Dr. Srinivas Murthy ably supported by AMC Committee. Dr. Murthy is a renowned Professor of Psychiatry from NIMHANS (Retd) and has been staff of the World Health Organization during 2000-2001 and 2004-2006. Dr. Murthy had generously donated the entire cash prize of the LOPEZ IBOR Award that he had received to AMC. The same is helping AMC aid the project ENRICH. We are sure under his leadership the project will help empower the caregivers of this vulnerable population across the country.

One major stress area for us is the strained financial position, evidenced by the financial results which are before the AGM. Even in these dismal circumstances, our donors have rallied magnificently and I am truly grateful to them for keeping AMC afloat. To each of them, we owe a deep debt of gratitude.

I am grateful to our indefatigable Secretary for her yeoman efforts in keeping AMC going in these trying times, ably supported by our competent staff. My sincere thanks to the office bearers and members of the MC in standing shoulder to shoulder in the greater cause of AMC.

I do hope the year to come will be better and that going forward, AMC will be at an even keel.

SECRETARY'S REPORT

It's my honour to be presenting the 60th Annual Report of The Association For the Mentally Challenged (AMC). It has been an enriching and gratifying experience as I have learnt as much as I have contributed in the last 6 years as the Secretary. I thank the Committee members for enabling a highly constructive partnership with the team working cohesively to take forward AMC's mission. My sincere thanks to the Treasurer Mr. Hegde for his support through the year. My regards to President Shri. K. Jairaj and Vice President Ms. Meera Ramchand for their support.

AMC has built a strong reputation in the space of caregiving for those affected with IDD and its journey in the last 62 years is testimony to its commitment to the cause and quality services. With the ever-increasing complexity of the environment that social sectors face, AMC has effectively managed to navigate the challenges and has been able to pivot its offerings.

As we all witnessed, the year turned out to be drastically different than any of us would have imagined and presented us with unforeseen challenges. AMC has been able to face these challenges with its innate ingenuity and move forward. Post the announcement of the first lockdown in March 2020, the Committee identified 70 families of AMC beneficiaries as most vulnerable due to their week economic status. Most of the parents of these beneficiaries who are drivers, daily wage workers and other such occupations had lost their livelihood. AMC Committee Members swiftly responded with their personal contributions and enabled supply of essential groceries and hygiene items to these families. This paved way for building support towards the Covid relief programme by way of fund raising and reaching out to donors.

One of AMC's key strengths is the partnerships it has been nurturing. Challenges however big could be faced better when we gather people around us. AMC's call for support to initiate the Covid relief programme received an overwhelming response from its well wishers enabling an expansive relief programme going on for the last 18 months.

These unprecedented times influenced the way the operations were led and prompted us to reassess our strengths. AMC has been working on building capacities of the team and build strong systems around programmes, talent acquisition, fundraising, impact, governance and leadership. AMC Committee has installed an open and transparent organisational culture based on core values of commitment, integrity and excellence. Our efforts continue to ensure a robust governance structure and strengthen key functional capabilities. These efforts have translated in AMC being a preferred partner and has renewed the confidence among all the stakeholders.

I laud the efforts of the staff at AMC for the resilience shown during these tough times and thank them for their support in driving the relief programme.

My sincere thanks to each of the donors and corporates for the trust and support without which AMC couldn't have embraced the challenges with vigour.

ACTIVITY REPORT

The special children and young adults are forced to be at home without the professional care they enjoyed at AMC. They were receiving life-skill lessons, vocational training, yoga training, sports training and would indulge in practicing various art forms including dance and painting. Also they would enjoy nutritious meal, seasonal fruits and porridge every day. The lockdown and aftermath of it has deprived them of this quality care and has brought distress in their lives. However, the earnest efforts of the Committee and the Staff have been ensuring that these families' difficulties are minimised with AMC's interventions.

SPECIAL SCHOOL:

There are 43 children enrolled at the school and the physical classroom sessions are not being held. The staff under Secretary's guidance started preparing the worksheets and other learning materials since April 2020 and started delivering them to each child's home. The special educators are preparing customized lesson plans for each child based on IEP and delivering the worksheets, learning materials, play equipment every month. Also videos addressing the topics complementing the Lessons prepared and are shared through WhatsApp application. The kids are enjoying watching their teachers explaining the varied topics using variety of colourful materials and accessories. Parents are immensely happy with the process. The hope is to engage the child positively as per the curriculum.

The transition has not been easy as distance learning may not effectively address issues like behavioural problems and gross-motor remediation. At the same time we also observed that few kids with anxiety about social interaction and academics have been responding better to the distance learning. Efforts are on to procure digital tablets that could be distributed with pre-loaded learning content among the kids.

The "Sponsor a Child's special education programme" at the school supported by individual donors and Give India in particular has been helpful at the school. HHH continues to support the school by funding the expenditure towards the transportation. AMC receives the State Government's aid towards the salary of only one special educator.

















VOCATIONAL TRAINING CENTRE: There are 46 trainees at the centre undergoing training in different vocations like weaving, candle making, kasuti work, making paper covers and pottery. AMC has been encouraging these adult trainees to continue practicing the respective vocations at home by supplying them the raw materials and sharing the skill demonstrating videos periodically.

SHELTERED WORKSHOP: Supports 17 trainees who are able to engage themselves in making various products under minimum supervision. They are engaged in making paper bags, cloth bags, candles, gift boxes, envelopes, photocopying and weaving. This unit has one instructor to monitor the trainees and support them. A sincere attempt to upcycle the used cloths and textiles has resulted in the centre making beautiful items like bags, purses and other utility products.

These adult trainees are being supplied with kits for weaving, knitting, paper-bag making and kasuti work. AMC is glad to share that 85 carpets, 45 mats are woven and number of paper products are made by the trainees at their respective homes during the lockdown period. The parents are happy that their wards are productive even during these disturbing times and are not loosing on the training process acquired at AMC.

DAY CARE CENTRE: This centre cares for 10 adults with severe degree of IDD. They are cared for and kept occupied with simple activities like making of paper covers, yarn winding, watering the plants, etc. The dedication of the staff in caring for these adults is highly appreciated by the parents and has earned their respect. We feel helpless as these individuals are not able to attend the centre.

SAMRUDDHI: AMC's unique imitative extending care to the families adds more value to the services offered to the beneficiaries as it facilitates programmes towards their empowerment. At the tailoring centre, the mask making project has been going on since May 2020. This project has made a huge difference for these mothers as they had an opportunity to get professionally trained and also take home a decent stipend. This has not only instilled confidence in them but also helped in improving their quality of life.

SELF HELP GROUP: The Self Help Group is playing a crucial role in lending continuous support to the families of beneficiaries with constant guidance and care extended through the year. Parents are helped with counselling sessions from the visiting psychologists.

The activities of this group are being led by Ms. Prema Varadarajan who with the help of the staff is offering counselling to the parents on various aspects of care for their wards at home. Through the Niramaya scheme the timely supply of medicines to the children and adults is being ensured.

GUIDANCE AND COUNSELLING CLINIC: A periodic care and counselling is provided by the visiting team of doctors and psychologists from NIMHANS. This facility continued with its services even during the lockdown by offering phychosocial counselling services over phone and has been addressing various challenges the beneficiaries and their parents are facing in caring for their wards at home. These teleconsultations are being arranged with the doctors and psychiatrists at the campus.

SUCCESS STORIES @ AMC:

Hemanth D. is very social and engages in all the extracurricular activities at the centre such as yoga, sports and quiz competitions. He enjoys coming to the centre and is able to take home a decent stipend with a sense of self-worth. He is a 23 year old young adult with mild IDD and joined AMC's vocational training centre as a 18 year old boy. He is an active learner and has picked up various vocations very quickly. He is able to make paper covers, weave jute mats independently. He also appeared for the 10th standard examinations. Hemanth has good mathematics skill and is trained to operate the photo copying machine. He is able to interact with the customers even with his limited speech abilities.



Anupriya is a 15 year old with mild IDD coming from a humble family. Though her condition was diagnoised early when she was 3 years old, no professional intervention was given to her. Only at the age of 12 on the recommendation of doctors from NIMHANS she joined AMC Special School in 2018. Anupriya was a quite girl but stubborn. She could write numbers 1-10 and write the names of her family members in Kannada. Slowly in few months she picked up writing numbers in English, write numbers 1-100 and say the weekdays and names of months.



She started socializing with her peers and participating in yoga and sports sessions. She is disturbed and misses her school. She looks forward for her teacher's video calls and is excited to receive the materials from the school. She has been positively engaged during the lockdown and has started learning names of fruits and vegetables; she is playing and learning with the materials and puzzles.

Under the guidance of her mother and special educator she has started practicing pre-vocational skills such as stitching and embroidery work. She is able to sew button. Anupriya has also been participating in daily chores and is able to help her mother. Her parents are happy with the improvement she has been making.

Special Educators share their experience....

"As the pandemic set in and the schools had to be closed, we had no clue of the way forward and quite shocked at the status of these children with special needs. Under the guidance of the Hon. Secretary, we were all encouraged to embrace the new challenge and pick up new skills and innovate.

We started with material preparation based on the curriculum that was being taught in the classrooms and sending them to each child. But there was no interaction with the child and no feedback on the child's response to the shared materials. So we began to prepare materials based on IEPs (Individualized Education Plan) and started distributing worksheets, drawing materials, puzzles and variety of learning materials like wooden blocks, games, crayons, workbooks etc., These materials are being sent every 15 days and the completed worksheets collected back for review by us. We call the parents at designated times in the day and gather about any challenges they may be facing in helping the children with the content. We are able to cover all the areas of development: functional, academic, fine and gross motor, art and craft, sports, daily living skills, & pre-vocational skills. Encouraged by the feedback, we started making videos addressing various interesting topics using colourful accessories. These videos are being shared on the WhatsApp application. Also we are offering guidance towards the various activities that the child can be engaged with at home. Children who respond well and enjoy talking over phone do express their joy at the video lessons and the play equipment sent. We feel helpless as the children are away from school for such a long time. We hope AMC's efforts help the parents brave the situation".

He doesn't cry easily but he would cry saying that he has to go to AMC and do mat, paper covers and importantly meet his friends and trainers. He is at a loss. We are ever grateful for all the help that the centre has been providing and special thanks to the staff for coming by bus and providing groceries and weaving materials to Micheal.

The happiness and the big smile on his face while receiving the weaving frame and raw materials is beyond words. He would immediately get ready to weave and is focussed on finishing. I have now realised the passion with which he attends to weaving. I feel I am not alone in this struggle because of the assurance that I could reach for help any time and seek support at AMC for the mental well being. No one does this. NOTES ON ACCOUNTS

1. Significant Accounting Policies

A. Basis of preparation of Financial Statements

- a) The accounts are prepared on historical cost convention and comply with the mandatory accounting standards issued by the Institute of Chartered Accountants of India
- b) Accounting policies not specifically referrerd to otherwise by consistent and in consonance with generally accepted accounting principles

B. Fixed Assets and Depreciation

- a) Fixed assets are stated at cost of acquisition or construction including directly attributable cost of bringing the assets to its working condition for its intended use
- b) Depreciation is charged as per the written down value method in accordance with the rates prescribed in the Income Tax Act, 1961

C. Revenue Recognition

- 1. Interest Income:
 - Interest income is accounted for on time proportionate basis.
- 2. General Donation:
 - General Donation received without any specified instructions are accounted as income on receipt basis
- 3. Specified Donation:
 - Donation received with a specific instruction regarding the end-use is not recognised as income.
 - A specific corpus fund is created for such donations and expenses incurred for such purposes are debited to the corpus fund.
- 4. Other Income:
 - In case of sale of products, revenue is recognised on sale value excluding levy of good and services tax as applicable.
 - All other income is accounted for when the right to receive the amounts is established and the amounts can be reliably estimated.

D. Foreign Currency Transaction

Transaction in foreign currencies is accounted at the exchange rate prevailing on the date of Realization



E. Taxes on Income:

The Association for the Mentally Challenged is registered u/s 12AB of the Income Tax Act, 1961 and does not need to pay any taxes as long as 85% of the income is spent for specified purposes. There is an option to accumulate more than 85% of the income if Form 10 is filed with the income tax as well. The Association for the Mentally Challenged has always strived to apply at least 85% of the income received for educational purposes every year. In the event the Association is unable to apply such 85%, Form 10 is filed. Therefore, no provision for Income Tax is being made.

F. Provision, Contingent Assets and Contingent Liabilities:
