FORE WORD

The Objectives of the RPDw Act 2016 the rehabilitation of the PWDs still executing in a miniature scale. So without strong direction neither project gathers sufficient momentum to success. Unless efforts are backed up by the legal frame work people will not take the issues seriously in order to ensure that negative attitudes are rooted out from the society. In such crisis of time corporate action i.e. public and private sector are basically needed to implement different activities. Corporate Social responsibility basically needed, falling which laws remain within the red tape of file.

In spite of many obstacles, organization systematically continuing different programmes with the assistance of ministry of social justice & Empowerment Govt. of India and SSEPD Dept. Govt. of Odisha in different district of the state Odisha. It has been continuing social mobilization, capacity building, Skill development training, physiotherapy services for senior citizens and therapeutically services including action oriented activities both in institutional and outreach setup for the comprehensive rehabilitation of intellectual disabilities as well as all category of PWDs (Divyangjans) as per RPwD Act 2016 for their inclusion in the society.

This is the welcome sign that inspires optimism and optimism in an accelerating element for the forth coming session 2020-21 are not different and despair. The dawning new hope which has set its eyes on new and higher goals of achievements will also bring new horizon of change for P.W.Ds.



The marginalized class of people considered as a disadvantaged segment of population in the community. Realizing this very disparity, a team of professional who has not only sensitive but also trained up in implementing developmental programmes, came together on a single platform to undo the injustice meted out to these unfortunate people. The efforts of professionals took a concrete shape in the late research (CRSR) which was registered as a voluntary organization under the relevant Act. To achieve the long term objectives, organization also be registered under various other Acts at status.

VISION STATEMENT

CRSR, as a philanthropic organization aims to promote model principles of egalitarian society and is closely linked to the basic human rights. It has been also rejuvenates the team spirit of the marginalized class of people such as persons with disabilities (PwDs), livelihood issues become all the more important on account of negative and discriminatory attitudes of the society and other complexities such as lack of accessible to transport, availability of conducive infrastructure and services to overcome various socio economic and political constraints faced by them. 3. To provide education & rehabilitation services to differently abled children, Orphan children and street children through special schooling, Integrated Schooling, Day Care center, Early intervention & Training Centre, Care Centre and Home management programme.
4. To undertake research design to develop new aids technology and techniques for educating and rehabilitating different categories of the differently abled.
5. To adopt & implement Inclusive Education for Children with disabilities at secondary level for the complete educational rehabilitation of children with special needs.

6. To rehabilitate and trained up differently abled individuals, as well as to find ways to integrate them in to their communities.
7. To conduct different types of human resource development-training programmes such are teachers training programme on special education and other professional/ Personnel's courses for rehabilitation PwDs and community as a whole.
- 8 To create awareness among the citizens on health care, reproductive child health, family planning, Sanitation and provide health care & education and rehabilitation services on the issues of HIV, TB, Leprosy, Cancer and Hepatitis etc.



MAJOR ACTIVITIES
(2019-20)

9.1. Identification/ Assessment Camps for Persons with Disabilities.

The identification & assessment of PwDs traced out the magnitude problems of deformities for fitment of proper aids/appliances. Organization has been continuing the identification & assessment camp for persons with disabilities with the co-operation of local level NGOs, Panchayat sammittees



and District administration in 09 (nine) districts of Odisha i.e. Bhadrak, Balasore, Cuttack, Dhenkanal, Jajpur, Keonjhar, Kendrapada, Mayurbhanj and Nayagarh by a team of rehabilitation professionals. During the year 2019-20, Organization conducted 08 nos. of identification camps and identified 603 nos. of persons with disabilities for distribution/fitment of aids & appliances in the above nine districts of Odisha.

9.2. Assistance to disabled persons for purchase/fitting of Aids/Appliances(ADIP).

As per the rights of persons with disabilities (RPwDs) ACT 2016, for the primary rehabilitation of persons with disabilities, personal mobility enhances the physical mobility to assume power over their lives.

Organization has been

continuing the systematic programme (ADIP) with the financial assistance of Department of Empowerment of Persons with disabilities, Ministry of social justice and empowerment, Govt. of India, in 08 (Eight) districts of Odisha i.e. Bhadrak, Balasore, Keonjhar, Jajpur, Kendrapara, Cuttack, Dhenkanal and Nayagarh. Organization liaisoning with district administration and panchayat sammittee arranged identification/assessment of aids and appliances camps for PwDs and distributed/fitment assistive devised through camp approach at the block head quarter. The professionals of the organization adopting the latest technology for fabrication/fitment prosthetic & orthotic appliances and distributed mobility aids like Tricycle, Wheel chair, Crutches and Elbow crutches, Walking sticks, Walkers, Smart phones, Daisy player, smart canes, etc. Our audiologist cum speech therapist after proper audiometric test fitted hearing aids to the identified PwD beneficiaries. CRSR has been Distributed/fitment 305 Nos. of assistive devices to 245 nos. of different categories of PwDs during the year 2019-20.

9.3. Clinical Services:

Organization has been providing different clinical services such as X-ray, pathology, ECG, Audiology & Speech Therapy, Occupational Therapy etc. since last 20 years and during the current year, 6503 nos. of beneficiaries are benefited through free of cost/ nominal cost of services by which they are easily diagnosed for availing the health services. The Persons with disabilities and senior citizens are



availed the services in free of cost. The detail unit wise beneficiaries are covered are mentioned below:

9.4. Observance of International Day for the Persons with Disabilities (PwDs):

To create awareness in the society on rights of PwDs, like each year, current year International Day for Persons with Disabilities was observed with the corporate action of District Administration (Social Security Section) & Samagra Sikshya Bibhaga (SSB), Bhadrak on 03.12.2019 at Sahid Smruti Bhawan, Bhadrak, Odisha. The programme was inaugurated by Sj. Shyamabhakta Mishra, Additional District Magistrate (ADM), Bhadrak, Sj. Pitambar Samal, Sub-Collector, Bhadrak. On the occasion of the day different programmes were organized among the children/ persons with disabilities under the guidance of Sj.



Sj. Sangram Sahoo, DEO of Bhadrak, Sj. Amaresh Panigrahi, DSP, Sj. Harendra Ku. Dehury, District Social Security Officer (DSSO), Dr. Bhagaban Parida, Chief-functionary of CRSR and. Sj. Jaladhar Mandal, IED Coordinator of SSB, Bhadrak.

On the eve of International Disabled Day, a district level Para Sports meet has been organized on 26.11.2019 among 300 nos. of Children with Disabilities from different inclusive schools and special schools of Bhadrak district where 32 nos. of Children with Intellectual disabilities and Cerebral Palsy won prizes on different events from our Special school.



Sj. Mishra, ADM of Bhadrak district gave his views that the PwDs are no more considered as non productive member of family. Today it is observed that they have skills and talent like normal persons in the community. Dr. Parida, the chief-functionary of CRSR, Bhadrak with details to explain about different categories of PwDs and how to provide them health, education, assistive devices and also aware them about different types of opportunities for their rehabilitation in the society. Sj. Dehury, DSSO, Bhadrak, gave his views if the parents of PwDs, community members have no positive mentality to help the PwDs especially the CWSNs future is in the darkness of uncertainty. At the end of occasion, a cultural programme conducted by the Dist. Administration where the differently abled children shows their performances and at last the winners of para sports meet were awarded by the invited guests on that day at Sahid Smruti Bhawan.

On this occasion, another prog. also arranged at the conference Hall of the Organization by the Rotary Club of Bhadrak where hon'ble MLA of Bhadrak Sj. Sanjib Ku. Mallick participated as Chief guest. In the occasion different cultural programmes organized by the children with disabilities and lastly prosthesis (Artificial) limbs were fitted among 07 nos. of PwDs.



9.5. Community Based Rehabilitation (CBR) Prog. for the PwDs:

Community Based Rehabilitation programme has immense value for the sustainable development of PwDs at the grass roots level within the utilizing of minimum resources in the target areas.

The Objective of the programme is to restore the persons with disabilities to needful activities and rehabilitation includes all measures aimed at reducing the impact of disability for individual, enabling his/her to achieve independence, social integration for their better quality of life and self actualization.

CRSR as an implementing agency has been continuing CBR programme since 2000-01 under Deen dayal Disabled Rehabilitation Scheme, Ministry of social justice & Empowerment Govt. India. The Programme has been continuing in the remote rural areas of Bhadrak district where services are not accessible to persons with disabilities. During the year 2019-20, community based rehabilitation services are provided to 793 nos. of PwDs in 55 villages under 05 nos. of Grampanchayats of Bonth block, Bhadrak District.

To trace out the Magnitude of problems in the target group of population, staff of the concerned programme started door step survey in the operational area. After door based survey services are provided to PwDs in the community as per

Individualized Plan (IP). Under social mobilization activities panchayat level PwDs committee formed which strengthen the voice of PwDs for their rights and social participation in all sectors of life. During the year 20 nos. of village level organization, 05 nos. of C.B.R committees (One in each G.P) formed and each committee consisted with the PwDs, Parents/ representative of PWDs, local PRI members, eminent persons,

representative of local NGOs, trained personnel/ professionals etc. The C.B.R committee systematically activated the programme to be implemented in the village/ Panchayats for the sustainable development of PwDs and even after project duration committee will continue the trend of activities for its sustainability.

To sensitize the PwDs and their parents it has been disseminated the knowledge and skills by the professionals through capacity building training and it also helps in wider knowledge of prevention and rehabilitation of disabilities. 178 nos. of PwDs and parents of PwDs were provided capacity building/ leadership training in all 05 GPs of project area by the trained professionals of the organization.

For increasing the purchasing power to empower the PwDs, organization continuing the activities of vocational training, formation of PwDs SHGs, Home based education and therapeutic management etc. which are inaccessible for rural PwDs. All the activities under CBR are planned and implemented with the involvement of PwDs and community for sustainability of the programme.

The differently abled women & Children with disabilities are mostly deprived from their rights in all aspects of life and spaced in the community. So in such precarious situations

the women with disabilities are ensured skill development training, Income generating programmes, health education and Self Help Groups (SHGs) at the grass roots level in the operational area. There are 07 nos. of Self Help Groups (SHGs) formed in 05GP and each group consisted with 06 to 10 members.

Aids/Appliances are basically needed for the primary rehabilitation of persons with disabilities (PWDs) those have increased their mobility and strengthen their purchasing power. Hence professionals of the organization identified 24 nos. of P.W.Ds and distributed/fitment aids/appliances under ADIP scheme. CBR personnel also be delivered basic rehabilitation services through home based management to 146 numbers of children with disabilities those are within the age group of 0-15 years and counseled to the parents and admit in special/ integrated schools as per their degrees disabilities.

9.6. Special School for Spastic (CP & MR) Children.

As per disability law, special children have right to education and realizing it without discrimination on the basis of equal opportunity to develop potential, sense of dignity, self worth and strengthening the respect for fundamental rights and human diversity, organization has been continuing "**Bhadrak Special School for Spastic (CP & MR) Children**", with the supporting of Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities, Govt. of India since 2006.

As per the theme of the special school, residents are delivered residential care services, learning achievement and sound system of environment which has been instilling their confidence individual freedom and reading the degrees of deformities through appropriate teaching learning materials and assistive devices to the resident of benchmark disabilities.



Apart from special education other activities such are regular health check up, Yoga, Physiotherapy/ occupational therapy, speech therapy, music therapy, psychological behavioral management and vocational & pre-vocational which are essential for their IQ development and behavioral modification and primary & secondary ADL intervention. During the current year 73 nos. children with intellectual disabilities are provided residential special schooling. The details class wise children enrolled in the special school cited below:

For Disseminating knowledge and skills to the parents of residents, Organization arranged 03 nos. of sensitization awareness programme and professionals imparted required training inputs in the field of disability to the parents/ guardians. For the social inclusion residents are free to participate in the different social events and programmes of International disabled day, Republic day, Independence day, Mental health day, Autism day and district level sports among special schools and children of Integrated schools etc.

9.7. Physiotherapy Clinic for Senior Citizens:

With the breakdown in joint family system and societal values which espoused such concerns and care for the elderly; find themselves and helpless with neither the family nor the society take responsibility for their care. There has been age related changes including bone density, reduce muscle strength, increase body fat and poorer co-ordination and stiffer joints. In such precarious situations to provide the health services and to maintain them functional organization has



been continuing physiotherapy clinic for senior citizens with the financial assistance of Ministry of Social Justice & Empowerment, Govt. of India since F.Y 2010-11 at Charampa of Bhadrak district, Odisha. During the current year 612 nos. of senior citizens are provided Physiotherapy services in the centre.



Our experienced physiotherapist after proper diagnosis and assessment delivered services with high standard therapeutic equipments such as laser therapy, short wave diathermy(S.W.D), Interferential therapy, muscle stimulator, ultra sonic therapy, computerized cervical thoracic and lumber traction, therapeutic bed, hydroculator, shoulder exerciser, wrist exerciser, multi exerciser gym, Treadmill, continuous passive motion machine (CPM), staircase, static cycle, foot massager and Paraffin wax bath, etc. to the senior citizens in free of cost. Organization also initiated to create awareness among the senior citizens by liaisoning with District head quarter hospital, Dist. Administration, placing banner & hoarding and advertisements in local medias to avail the facilities in free of cost.

9.8. School for the Mentally Retarded Children:

The children with mentally challenged is one of distressed segments of population among all categories of P.W.Ds in the community. The school for mentally retarded children in located where community dominated with S.C & S.T communities. Organization has been continuing the Special school with the support of Dept. of Social Security and Empowerment of Persons with Disabilities (SSEPD), Govt. of Odisha at Jharbelda under Sadar block of Keonjhar district, Odisha.

As per the objectives of the special school organization created a conducive environment which has been improve the mental state of thought of the residents. It has been also be delivered care, special services learning achievement and friendly system of environment which has been instilling their confidence, individual freedom and reducing neurological problems in gradual process of time. There are 41 nos. of children with mental retardation (M.R.) are enrolled in the special school cited below:

The Special educators, Speech therapist, Physiotherapist and Psychologist delivered basic rehabilitation services i.e. early identification, primary intervention, secondary intervention, infant stimulation, formal & non formal education, adapted physical education, ADL, behavioral management, natural environment training, pre-vocational & vocational training etc. Organization also conducted sensitization training programmes inside the premises of the school time to time. The professionals imparted health education, knowledge & skills in the field of disability to the parents of residents.



The residents of the special school are provided the opportunities to participate in local, National & International programmes .i.e. Independence Day, Republic day, international day for the persons with disabilities to improve the competitive spirit among the special children.

9.9. KSHYAMATA EXPRESS (A mobile Rehabilitation Unit):

Kshyamata Express is an outreach programme for Early Detection, Care and plan of actions for rehabilitation measures of Children with Special Needs including Persons with Disabilities, Geriatrics, Transgender, Beggars, Destitute & Substance abuses under SSEPD Dept., Govt. of Odisha. Services provided under Kshyamata Express are identification & assessment of 21 types of disabilities as per RPwD Act 2016, on

the spot UDID enrollment, Audiological Test / BERA testing, Psychological testing, Vision testing/assessment, vocational assessment, assessment & measurement for aids/appliances, psychological Counseling, therapeutic assessment services & counseling, Self employment & guidance, Pension linkages, PwDs



Activities under Kshyamata Express (Registration, Assessment, Vision test, Physiotherapy , UDID registration, Audiometric test, assessment & measurement for aids/appliances, Psychological assessment, Social Counseling etc.)

Marriage Incentive promotion, Scholarship facilitation, Awareness & IEC activities etc.

CRSR, Bhadrak with the financial assistance of Social Security & Empowerment of Persons with Disabilities (SSEPD) Department, Government of Odisha successfully completed the Kshyamata Express camp at Bhadrak, Balasore, Bargarh, Deogarh, Jajpur, Keonjhar, Mayurbhanj, Sundargarh district of Odisha with a team of Doctors, rehabilitation professional, Optometrist, Physiotherapist, Prosthetist & Orthotist, Audiologist cum Speech Therapist, Psychologist, Social Worker, Computer Professional and other supporting staff.

As per norm of the programme, Organization organized 93 nos. of panchayat level camps in 07 districts and services delivered to 9792 beneficiaries. The detail district wise outputs mentioned below:

Organization also issued 432nos. of ID card to avail the benefits from state government those PwDs are deprived of benefits due to not availability of Disability certificates. Govt. of Odisha authorized to professional of Kshyamata Express to issue ID card for instant getting the benefits from Sate Government.

9.10. Low Vision Centre:

Most of people's deteriorated which have been urgently needed comprehensive preventive measures to combat existing rising trend of this category of people in the community. As per our experience when one's vision deteriorated he/she affect upon finds difficult to perform task of everyday life. Over the plight of situations of above lines Organization has been continuing a low vision centre since FY 2016-17 at Bhadrak with the assistance of Department of Empowerment of Persons with Disabilities, Govt. of India.



The main objective of the Low vision centre is to deliver identification, assessment, counseling and training with low vision aids, prescribed appropriate optical aids and mobility training which will improve the visual efficiencies and social activities, referral for appropriate medical treatment where necessary. Besides medico rehabilitative services the ophthalmologist imparted health education and advice special services to improve their visual efficiency in gradual process of time. During the year 2019-20, Organization delivered services to 868 nos. of persons with low vision from Bhadrak, Balasore, Jajpur, Keonjhar and Mayurbhanj districts of Odisha. The professionals delivered mobility training to the children with low vision below 15(fifteen) years for improving their vision efficiency to the maximum extent possible.

9.11. Therapeutic and Rehabilitative Services for persons with Intellectual Disabilities:

Over twenty four years of experience CRSR initiated activities for the distressed persons those are at grass roots level in Bhadrak and its adjacent districts. Organization continuing the residential therapeutic & rehabilitation centre for Persons with intellectual disabilities since 1st April 2016 with the managerial support of Dept. of Social Security & Empowerment of Persons with Disabilities (SSEPD), Govt. of Odisha, at Dahanigadia, Charampa, Bhadrak.

The objectives of the programme is to provide the respite care, harness their abilities, skills, competencies and facilitating optimal functioning in order to provide the maximum possible measures

of social participation and self-reliance of independent living. The professionals of the concerned programme i.e.

Physiotherapist / Occupational therapist, Audiologist cum Speech therapist, clinical psychologist, medical Doctor,

special educator, Vocational instructor after proper assessment delivered service systematically as per plan.



A range of services provided to the residents in the centre i.e. strengthening exercises, stretching exercises, joint manipulation, improvement of neuromuscular condition, fine motor activities, residential care (respite home), health checkup, vocational and pre-vocational training, art & Craft training, speech therapy, Yoga Therapy, Psychotherapy, Informal education, Daily living skills and adaptive skills, social interaction, behavioral modification training. Caregivers also plays an important role to perform the ADL activities of Children with intellectual Disabilities such as bathing, toileting, feeding care & maintenance, daily exercise as per the need. During the year 2019-20, there are 55 nos. of intellectual disabilities are delivered services in the centre.

9.12. Skill Development Training for PwD youths on DTP & Print Publishing Assistant:

Organization with the financial assistance of Social Security & Empowerment of Persons with Disability (SSEPD) Dept., Govt. of Odisha, successfully completed the first batch residential training programme on DTP & Print Publishing Assistant with intake capacity of 30 nos. of PwD youths from 02.08.2019 to 29.10.2019 with duration of 500 hrs. and 72 days. A screening camp also

conducted for the PwD youths on 15.07.2019 at the conference hall of the Organization for admission into the relevant trade. There are 30 nos. of PwD youths (both Boys & Girls) selected for admission on DTP & Print Publishing Assistant training course.



The training programme conducted by the experienced Instructors appointed by the Organization for the said programme both in lecturing cum participatory process and

organization provided training materials, boarding and lodging facilities along with other basic requirements to the trainees. Theory and practical classes continued as per the prescribed time schedule. Theory and practical examination also held after completion of the course. Our experienced instructors emphasized on D.T.P (Software & Hardware) with theory and practical classes. Trainees are systemically provided about MS Office Word, Excel, PageMaker, PowerPoint, Adobe Photoshop, Coral draw, Odia DTP, Internet. Trainees are also be trained-up on screen printing and upset printing. After

completion of the training prog, Organization issued certificates to all the trainees who have successfully completed the Skill Development training programme and also taking initiatives for the placement of the trainees.

9.13. Observance of World Mental Health Day:

The former lunacy Act was replaced by the modified mental health Act 1987. To success the objectives of the Act, organization in collaboration with District Legal Aid Services Authority (DLSA), Bhadrak, commemorated the observance of Mental health day on 10.10.2019 at the conference hall of the organization, Charampa, Bhadrak. Mrs. Pranati Saha, Dist session judge cum Chairperson D.L.S.A, Bhadrak participated as chief guest and Sj. Janak Rout, Registrar, Smt. Aparna Mohapatra, secretary D.L.S.A, Sj. Priyaranjan Ojha, Junior Civil Judge, Sj. Rasminarayan Mishra, Second class judge of judicial Dept., Lipsa Rout and Dr. Bhagaban Parida, chief functionary of CRSR as guest of honour.

Mrs. Saha, Dist session judge cum Chairperson, gave his opinion that the persons with mental illness are a part of inclusive society and state shall remove barriers to ensure that they have full and equal opportunities to receive treatment, care & support and live life with dignity. Sj. Janak Rout, Registrar explained in his speech, the roles and procedures of laws to assist the persons with mental illness from legal and humanitarian fronts. Sj. Ojha, Junior Civil Judge, discussed with participants in a participatory process over the need of early diagnosis and how to deliver care and services to constraint the deteriorated condition of the persons with mental illness. Smt. Mohapatra, secretary of DLSA, Bhadrak, spoke that in such crisis of time corporate action basically needed to rehabilitate the persons with mental illness in the community, Dr. Parida, the chief functionary of CRSR explained the existing situation of mental illness in Bhadrak district and he also gave his opinion about this vulnerable segment of population live in a society that is inclusive & supportive to both persons with mental illness and normal persons.



On this occasion another sensitization prog. on Mental Health Act arranged at our New Hope- Care & Protection of Spastic Children centre where First track magistrate and Chairperson of Dhamnagar court, Smt. Bishnupriya Samantray inaugurated the prog. In this sensitization meeting Sj. Debasis Samal, advocate of Odisha high court, Sj. Lagnajit Behera, Additional Tahasildar, Dhamnagar, Sj. Amarendranath Mohanty, Govt. advocate of Dhamnagar Court actively participated and gave their opinion and projected emphasis how to rehabilitate the person with mental illness in the society. There are around 175 (One hundred seventy five) nos. of special children with mental illness/retardation, parents of such segment of population, representatives of local NGOs, teachers, students and community members participated in the programme.



9.14. Care & Protection of Spastic Children:

CRSR with the Financial assistance of SSEPD Dept, Govt. of Odisha continuing a Day Boarding Centre for Children with Cerebral Palsy and Intellectual Disabilities at Dhamnagar Block of Bhadrak district.

The main objectives of the schematic programme to identify the Psychological & therapeutic needs of children with cerebral palsy, assess their capacity and place them in group according to their management plan.

The Basic services i.e. early detection, therapeutic management, development of communication skills and support of assistive devices which enhance their level of functional activity of daily living. Time management of parents and can attend therapy sessions regularly, home based therapy management, awaring parents about the programme and other Government schemes so that they can take maximum benefits from Govt. 


