## **INTRODUCTION:**

*Even after such long years of Independence of our country the persons with disabilities are amongst the most marginalized section of the society. One of the biggest challenges being faced by the policy planner and implementing agencies is to provide rehabilitation services to the unreached persons with disabilities living in rural area and urban area. Although most of the efforts have been made so far in this regard still the benefits are not reached to the unreached as expected. The so-called provisions do not provide scope and ample opportunity to every body according to his/her needs.*

*'Service to mankind is service to God', keeping this in mind the Rural Organization for Social Elevation (ROSE) came into force in the year 1996-97. This organization has been committed to the cause of persons with disabilities and to provide them equal opportunities with their full participation.*

*Since inception this organization has been implementing various welfare and developmental programmes i.e. Integrated Education for the Disabled Children (I.E.D.C.) Establishment of special school for the intellectually challenged and capacity building of teachers and parents and removal of architectural barriers for the children / persons with Loco motor impairment, Procurement of disability certificates in Mayurbhanj district of Orissa State. Residential & Day Care Center for M.R., C.P., Autism & Multiple Disabled, Vocational Training Center for Disabled Students and Training of Caregivers (National Trust).*

## **VISION:**

*Empowerment of the disadvantaged community has been proposed in such a way that they can utilize their potentials and resources for their all round development in a suitable manner.*

*This Organization has undertaken works like ensuring implementation of P.W.D. Act – 1995 and RPWD Act 2016 undertaking of action oriented projects, promoting of innovative strategy assistance devices etc, empower the persons with disabilities cover National Trust Act 1999.*

*The Ministry of Human Resource Development Department of School Education & Literacy was kind enough to sanction the project for the cause of children with disabilities and bring them in to mainstream of society. By implementation of the I.E.D.S.S. Programme 380 nos. of children with disabilities have been identified and 140 nos of students were admitted in normal schools 17 special teachers (Itinerant teachers) and 1 helper have been appointed to take care of these children.*

*We conducted a training programme for the Headmasters of High Schools were also conducted for the regular class - room teachers, parents are also trained in a phased manner on home management of their CWSN.*

### **SURVEY & IDENTIFICATION**

*Survey and Identification of the persons with disabilities is a continuous programme of the ROSE. A door to door survey campaign and village corner meetings were organized in 6 Blocks i.e. Khunta, Barsahi, Kuliana, Bangiriposi, Barpada and Gopabandhu Nagar Blocks of Mayurbhanj District for facilitating identification survey of children and persons with disabilities on composite area approach basis.*

### **ESTABLISHMENT OF SPECIAL SCHOOL FOR CHILDREN WITH INTELLECTUAL DISABILITIES**

To fulfill the organization's objectives and to provide services to the moderate and severe categories of intellectually disabled children a special school for the intellectually challenged has been established in the year 2003-04 at Baripada in the headquarters of Mayurbhanj Dist. The school is functioning at Raghunathpur in a rented building. The school is catering Educational & Training needs of 65 children with intellectually challenged. It is the only school in the district for the intellectual disabilities. District SARVA SIKSHYA ABHIYAN has already identified this institution as resource center for the Mentally Challenged and G-I-A Received from SSEPD Deptt. Govt. of Odisha.

### **ESTABLISHMENT OF ROSE SAMARTH CENTRE(NATIONAL TRUST.**

A Samarth Centre (National Trust) established in the year 2017-18 the centre catering Educational & Training needs of 30 children with intellectually challenged.

### **ESTABLISHMENT OF ROSE THERAPY CENTRE(SSEPD DEPTT. GOVT. ODISHA)**

A Therapy Centre (SSEPD DEPTT.GOV.T.OF ODISHA) established in the year 2017-18 the centre catering Educational & Training needs of 40 children with intellectually challenged.

Specially trained teachers, dedicated menials and well constituted managing committee have supported the school. The managing committee sits at regular interval for the services of the children with mentally challenged. The managing committee consists of the following persons:-

*The curriculum prescribed by the National Institute for the Mentally Handicapped which is also followed in other schools for the mentally challenged in this state is also followed in the school run by this organization.*

### **AIDS AND EQUIPMENTS**

*This School has been equated with some aids and appliances supplied by the Sarva Sikshya Abhiyan, Mayurbhanj. The management request for further support from the Sarva Sikshya Abhiyan for purchase and procurement of essential in-door and out of door materials required for fulfillment of the needs of this children with disabilities.*

### **FORMATION OF S.H.Gs.**

*The organization (ROSE) had taken initiative for formation of self help groups in Mayurbhanj District. 8 (eight) S.H.Gs. were formed for normal categories of women and 8 S.H.Gs. for person with disabilities. T The organization has also taken initiative for linkage of the groups with micro finance.*

### **SPECIAL HEALTH/ MEDICAL CAMPS**

*The health intervention was focused on making persons with disabilities functionally self reliant by reducing the extent of their disability. ROSE organized medical camps to assess the improvement and interventions required amongst the various disabled categories. Referral services were provided to those by the Govt. Hospitals who require further assessment and our organization supply medical forms.*

### **VIABLE ECONOMIC PROGRAMMES**

*As the economic bright conditions help to build up confidence and capacity of the persons with disabilities for self-reliance, this Organization organized prevocational training programmes for the intellectual disability.*

### **HOME BASED MANAGEMENT**

*The organization provides home-based management training to the parents, Siblings and out of school persons with disabilities. The home-based management training is being provided to them at regular intervals.*

### **AWARENESS PROGRAMME**

*The organization organize two awareness programmes for the year 2010-11 that is District Level Sensitization Programme for Community Members , Parents of Children's with MR,CP,MD and Autism and Anganwadi Workers.*

*ROSE organize a awareness and training programme for the headmasters/headmistresses of high schools regarding Integrated Education of Disabled at Secondary Stage in the District of Mayurbhanj District.*

### **OBSERVGATION OF INTERNATIONAL DAY FOR THE DISABLED**

*In collaboration with Sarva Sikshya Abihyan/ DPEP and District Administration this organization has been observing the International Day for the Disabled on 3rd December each year. For this purpose a sports meet and cultural programme are useally organized among the children with intellectual disabilities and non-disabled children.*

- 8. Formation of Residential Schools for the ST/SC Students.*
- 9. Formation of Residential School for the Blind, Deaf and M.R.(Girls) students.*
