The Sansthan is also registered with National Trust Act 2099-2000 to work with the above children The Sansthan is also registered under PWD Act 1995.

It is also running a special school for hearing handicapped children and intellectual disable namely "Jagat Narayan Viklang Sansthan" and a teacher's training center (Diploma in Special Education (ID) & (HI) recognized by Rehabilitation Council of India New Delhi.

The SAMARTH Scheme is running a separate rented building at 201/1E, Prayag Puram Naini, Prayagraj and special school and teacher's training center program in separate rented building.

3. SPECIAL SCHOOL :-

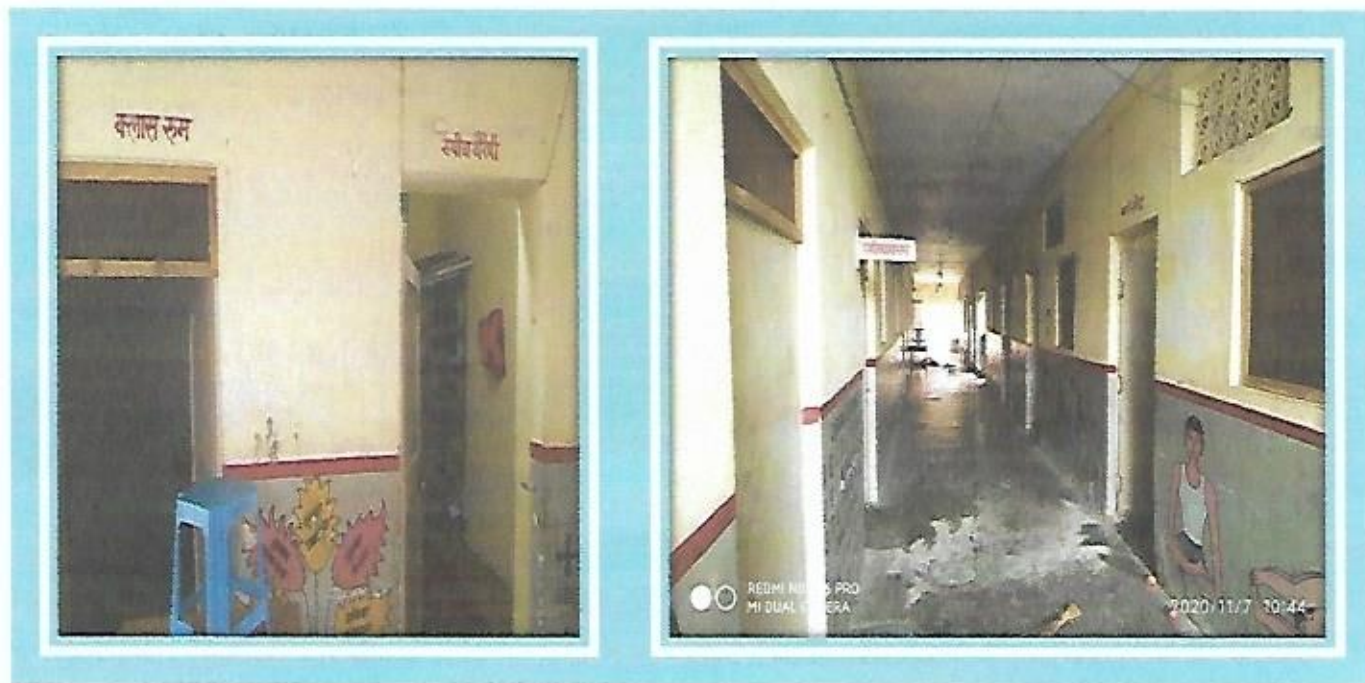
The organization is also running a special school namely "Jagat Narayan viklang Sansthan " Naini, Prayagraj. Hearing handicapped children and Intellectual Disabled children are getting special education. Under the special school the Sansthan is providing special education, educational rehabilitation for development of daily purpose of life.

62 Hearing Impaired children and 29 Intellectual disabled are getting special education benefits in the school. The Sansthan is trying to develop their communication skills, language development, speech development, self-help skill, care them self and others development as per their needs.

Special educator (vocational trainer) (02), Physiotherapist or Occupational Therapist (01), (5 Days) Caregiver (03), Aya(02), Cook (01) have been appointed under the scheme.



HUMAN RECOURSE: -

The organization is running human resource development center for the hearing handicapped and intellectual disabled. This program is recognized by Rehabilitation council of India new Delhi. Under the program we are providing Diploma in special education Hearing handicapped and intellectual disabilities (D.Ed. SE (HI) and D.Ed. SE (ID). It is two years' program designed by RCI. This diploma is equal to BTC of the state government and candidates have an opportunity to get employment in the general education under the state government the admission of the candidates in diploma is subject to Rehabilitation Council of India (RCI) New Delhi its terms & condition for each academic year. The intake capacity of the organization is 30 D.Ed.SE (HI) & 30 D.Ed. SE (ID) approved by the council.

Examination and certificate is providing by the NBER (National Board of Exam in Rehabilitation) of the Rehabilitation Council of India. The RCI have authorized to the "National Institute of the Government of India" to conduct diploma level examination on the behalf of NBER, RCI New Delhi and released the mark sheet and certificate to the candidates.

4. COUNTINUEING REHABILITATION PROGRAM (CRE):-

The Organization conduct CRE program for the Rehabilitation council of India (RCI) registered professional / personal special educators. It is 5 days 3 days or Seminar Workshop are also six-month online program which is approved by RCI New Delhi. The purpose of this CRE program is to update special educators working for disabled children and renewal of RCI registration for the working professional / personal.

5. EARLY INTERVENTION :-

Our target is troubleshooting of the children with skill not develop under the program.


