**Progress Report 2024-25**

Swami Vivekanand Shiksha Evam Samaj Kalyan Samiti- Commonly Known as **SVSESKS** was initiated by an enthusiastic group of youths in 1990. It was formally registered in 1993 under societies registration Act 21, 1860. It has been registered under Income tax Act 12A registration No. 476/00-01 , registered under I.T. PAN No. AAJAS9704K , registered under state planning commission U.P. No. 1081 (NGO DARPAN) , **SVSESKS vision** is to promote the integrated and sustainable Development among the poorest and the most marginalized section of Society especially women. Our **mission** is to initiate the process of community empowerment by Organizing and informing them towards their rights and entitlements and bringing them in to mainstream of integrated development & local Self governance.

**1- The National Trust (Ministry of Social Justice & Empowerment, Government of India) –** Working for the welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities. Our Organization has been registered for , GHARAUNDA Scheme under The Natinal Trust.

**Gharaunda Group Homes Scheme –** The objective of Gharaunda scheme is to provide an assured home and minimum quality of care services throughout the life of the person with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities and ensure adequate and quality care service with acceptable living standards including provision of basic medical care from professional doctors. The National Trust offered Set Up Cost for the best implementation of the project. SVSESKS has started this centre since 8<sup>th</sup> March 2016 with 13 registered beneficiaries (PwDs), inaugurated by Sri Raj Bahadur Singh (District Disability Development Officer, Sant Kabir Nagar). Which increased up to 17 PwDs in month May 16 to Jan.17 and 18 PwDs in Month Feb.and March 2018. One PwDs has been linked with employment by Envelope Making and others are learning this trade and some are learning 'garland Making'. We are making them capable to earn by vocational training inspite of proper caring. At present 20 PwDs under National Trust are enrolled in our group home Gharaunda. All are preparing envelope and earn for their livelihood. All registered PwDs are under BPL category, their income certificates are issued by SDM/ Tehsildar (Revenue Department) . AADHAR Card has been issued to all registered beneficiaries (PwDs) in a camp. We offer them dress/ cloth time to time. Sports facilities are also available for them. We arranged their Tour for Historical famous Palace ' Sant Kabir', Maghar. All have been registered and renewed for Niramaya Health Scheme.

**Niramaya –** The objective of 'Niramaya' scheme is to provide affordable Health

Insurance to persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities. Insurance cover upto Rs.1.0 lakh on reimbursement basis only. Scheme. All have been approved under Niramaya Scheme by The National Trust.


**Independence Day & Republic Day Celebration** - All registered PwDs under National Trust Disabilities in Gharaunda Center presented Nukkad Natak 'Krishan - Sudama' songs and speech etc. It was very attractive. Parents of the PwDs and other audience praised the program.


**LPC Meetings** - Every month We call LPC (Local Project Committee) meetings to trace their ideas about the change/progress in PwDs under National Trust, enrolled in Gharaunda center. Committee also monitor the program, management, infrastructure, sanitation and pure drinking water etc. We follow their suggestions.

**Physiotherapy, Counselling and Sports facilities** are also provided to all registered PwDs regularly.

**Tour at Historical Palace (Sant Kabir Maghar)** - Arranged for 20 PwDs under Gharaunda center, where PwDs were very happy and felt peace. PwDs are also part of society and they have also talent and improve their future by change in activities.

- 2- **Vocational Training** - Cutting Tailoring and Beautician training was also sponsored by Organisational Assistance only. 110 female youth have achieved training for six months.
- 3- **Pure Drinking Water Awareness Program** -  
SVSSKS organized a public meeting regarding Pure Drinking Water Awareness Program. Open session are also invited, in which many questions are put up in relation to ignorance about many diseases cause of Pure Drinking Water and government facilities, **pollution of water resources**, which creates many dangerous diseases on account of self carelessness. SVSSKS distributed Pamphlets and camp was organized in which it was found that mostly people do not know about the educated them about cleaned drinking water and water resources at Block - Mehndawal and Baghauri District - Sant Kabir Nagar. This program was organized by organizational assistance only
4. **Environment Awareness Program with Plantation** - Public Meeting was organized by Organisation in which 250 persons were participated. 500 trees were planted.
- 5- **Cultural Program** - SVSESKS has organized two days cultural Program on the Occasion of 15<sup>th</sup> August and 26<sup>th</sup> January.
- 6- **Women Empowerment Awareness Program** - Public meeting was organized for the Empowerment of women on 8<sup>th</sup> March in which focused on female programs launched By Governments. 50 Female SHGs were formed and linked with Banks.
- 7- **Collaboration with district Authority** -  
SVSSKS is member of district level steering committee as child Labor, bondage labor, flood etc. SVSESKS is also member of Local Level Committee of district Sant Kabir Nagar under National Trust, Ministry of Social Justice, Govt. of India, New Delhi. There is good understanding between district authorities and executives of SVSESKS.
